AVAILABILITY

This schedule is available for residential service for dwellings used for domestic purposes. This schedule is not available for service through a single meter to multiple-family dwellings, rooming houses, etc., not for service to two or more dwellings.

In addition to the above charges, a Net Energy Cost Adjustment charge will be added on a per kWh basis when necessary. See Net Energy Cost Adjustment Clause schedule for current adder.

NET MINIMUM

The total net monthly bill, calculated as above, shall be not less than \$28.00 per month.

LATE PAYMENT

After twenty (20) days a late fee is charged to any outstanding balance and the account becomes subject for disconnection. Services disconnected for nonpayment will be restored upon payment of past due amount including late fee plus a reconnection charge. The charge for reconnection will be \$25.00 if the reconnection is made during regular business hours Monday - Friday 7:30 am - 4:30 pm, and \$50.00 if the reconnection is made after hours Monday – Friday between the hours of 4:30 pm and 8:00 pm. Any reconnection requests after 8:00 pm will be completed the next business day during regular business hours. No reconnections will occur on a Saturday, Sunday, or an observed holiday.

PILOT FEE AND SALES TAX

In addition to the charge based on monthly rates as computed above, the total monthly charge for service is subject to applicable sales tax PILOT Fee. See Schedule A for current PILOT rate.

## CONDITION OF SERVICE

1. Voltage, phase and frequency of energy supplied under this schedule shall be as specified by the City.
2. Service under this schedule shall be furnished for the sole use of the Customer and shall not be resold or sub-metered.
3. Service shall be supplied through a single meter unless authorized by the City. At the request of the Customer, separate meters may be retained, in which case each meter shall be billed as a separate customer.
4. Welding, x-ray, or other equipment characterized by severe or fluctuating demands, shall not be served under this schedule.
5. Service will be discontinued twenty (20) days after the date of a bill for nonpayment.
6. A reconnection fee will be charged to any customer requesting a meter be reconnected after it was shut-off due to nonpayment.
7. All motor driven devices of 1 ½ HP capacity or larger must be operated on a nominal voltage of 208 volts or higher. All permanently installed electric heating devices shall operate at 208 volts or higher.
8. All motors greater than 3 horsepower must be approved by CMU.
9. A connection fee will be charged to any customer requesting a meter be reconnected at a service address not previously connected for same customer.
