

**CHILLICOTHE MUNICIPAL UTILITIES
COMMERCIAL SERVICE (NON-DEMAND)
Effective: 4/1/2026
CO01, CO08, CO12**

AVAILABILITY

This schedule is available for service for commercial establishments and for combined commercial and residential locations within the urban area of the community, or served from a common low tension network serving such area for usage up to 5,000 Kwh per month, or a connected load of 25 Kw or less. This schedule is applicable for Churches regardless of connected load or usage. This schedule includes buildings not located on or contiguous to the lot of an occupied permanent residence and is not occupied as a permanent residence.

RATE

Customer Charge	\$60.00
Energy Charge-kWh	\$0.0928 per kWh

In addition to the above charges, a Net Energy Cost Adjustment charge will be added on a per kWh basis when necessary. See Net Energy Cost Adjustment Clause schedule for current adder.

NET MINIMUM

The total net monthly bill, calculated as above, shall be not less than \$60.00 per month.

LATE PAYMENT

After twenty (20) days, a late fee is charged to any outstanding balance, and the account becomes subject to disconnection. Services disconnected for nonpayment will be restored upon payment of the past due amount, including late fee, plus a reconnection charge. The reconnection charge will be \$25.00 if the reconnection is made during regular business hours, Monday-Friday, 7:30 am - 4:30 pm, and \$50.00 if the reconnection is made after hours, Monday-Friday, between the hours of 4:30 pm and 8:00 pm. Any reconnection request after 8:00 pm will be completed the next business day during regular business hours. No reconnections will occur on a Saturday, Sunday, or an observed holiday. Instrument metered customers will be subject to additional disconnect and reconnect charges.

PILOT FEE AND SALES TAX

In addition to the monthly rates computed above, the total monthly charge for service is subject to applicable sales tax and PILOT Fees. See Schedule A for the current PILOT rate.

CONDITION OF SERVICE

1. Voltage, phase and frequency of energy supplied under this schedule shall be as specified by the City.
2. Service under this schedule shall be furnished for the sole use of the Customer and shall not be re-sold or sub-metered.
3. Service shall be supplied through a single meter unless authorized by the City. At the request of the Customer, separate meters may be retained, in which case each meter shall be billed as a separate customer.
4. Where the Customer's use of welding, x-ray, or other equipment characterized by severe or fluctuating demands, necessitates the installation of additional or increased facilities (including distribution transformers, service conductors or secondaries) solely to serve such customer, the monthly demand charge shall be \$2.00 per kVa of transformer capacity required to serve such load.
5. All motor driven devices of 1 ½ HP capacity or larger must be operated on a nominal voltage of 208 volts or higher.
6. All motors greater than 3 horsepower must be approved by CMU.
7. The maximum of any single-phase motor shall be 5 HP.
8. All polyphase motors of 25 HP and larger shall be controlled by reduced voltage starters. Reduced voltage starters shall be of the auto transformer, resistor, or part winding type.
9. When a customer's usage reaches 2500 kWh for any one month, or the connected load is over 25 kW, the City shall have the right to install a demand meter and place the customer on the Large Commercial Rate for a period of twelve (12) successive months.
10. Service will be discontinued twenty (20) days after the date of a bill for nonpayment.
11. A reconnection fee will be charged to any customer requesting a meter be reconnected after it was shut-off due to nonpayment.
12. A connection fee will be charged to any customer requesting a meter to be reconnected at a service address not previously connected for the same customer.
